Regional Delegate Report October 6, 2018 • Gillette, Wyoming

WCNA was the largest world convention to date and hosted around 22,500 addicts in recovery. It was truly amazing. Final official numbers are not released yet, but we will report more when we know more. The next WCNA - 38 will be hosted in Melbourne, Australia in 2021.

THE MEMBERSHIP SURVEY is available online at na.org/survey or under the Projects and Survey tab under for our members. This is an important PR resource that helps others outside the fellowship see NA as a viable program of recovery. The survey takes place every 3 years. Please spread the word in your areas and also take the survey yourself. Deadline is Dec. 31, 2018. In addition to the Membership survey, there is an NA Way reader survey available online as well. If you are a reader of the NA Way, or ever have been, please complete that survey too.

PROJECTS - As you know from this morning's workshop, **The Spiritual Principle a Day** meditation book is underway and input is being gathered now. All the workshop material we went over the morning is available at na.org. Please make sure, if members are submitting, to sign their submissions as a release to use the information.

The Mental Health/Mental Illness IP project was rated a higher priority and is a little further along. 794 surveys were completed and information from those are being used to frame the IP. The workgroup met recently and I believe they may possibly be requesting more information for the pamphlet. The anticipated release date for a draft for fellowship review is February 2019. Please share your thoughts and questions with the World Board by email at world-board@na.org.

WSC of the Future workgroup will hold it's first face to face meeting at the end of November. The webinar for WSC participants this morning was focused on that.

Local Service Toolbox Project is still being worked on with materials available on PR, Planning and H&I Basics. CBDM Basics is out for review, as is Convention/Events Programming. Phoneline Basics has been released and is available at na.org.

ISSUE DISCUSSION TOPICS have been updated and are now available online. The 3 chosen for this cycle are Carrying the NA Message and Making NA Attractive, Attracting Members to Service, and Drug Replacement Therapy (DRT and Medication Assisted Treatment (MAT) as it relates to NA. We look forward to workshopping these with you in the future.

REGION WORKSHOPS - Gail and I would like to start scheduling workshops in the areas and would like a little time on the agenda to discuss the parameters of this.

I'm requesting \$134 for travel today.

A Guide to World Services In NA 2018-2020

This draft of GWSNA includes revisions to reflect decisions made at the last World Service Conference. Changes are all reflected in colored print. This draft will be out to delegates for 90 days. Please let us know before the end of October if you see any errors or anything you believe was not captured accurately. We will incorporate your input and update the table of contents, and then we will produce a final GWSNA that will be posted to www.na.org/conference.

I would appreciate it if you could forward this to the appropriate party.

I was reviewing the draft for the GWSNA that was provided on the drop box. I noticed that on page 66 of the draft the below that is crossed out and in red letters. I also searched the document to see if this was placed elsewhere and I could not locate it. Is this crossed out for a reason? I found that this motion did pass, should it not be crossed out?

Page 66 of the draft -

- Decided that any Zonal Forum with two or more zonally seated regions or communities
 that are not seated at the World Service Conference, may choose to send one Zonal
 Delegate to the World Service Conference to represent those regions or communities.
 These zonal delegates have one vote. They are eligible to receive the same funding as
 regional delegates and may choose to bring an Alternate at their own expense.
- Decided that Alternate Zonal Delegates may attend the WSC with the same rights and limitations as is currently offered to Alternate Regional Delegates.

Motion #21 Australia Region and Aotearoa NZ Region

If motion 18 is not adopted then the following will not be offered.

Alternate Zonal Delegates may attend the WSC with the same rights and limitations as is currently offered to Alternate Regional Delegates.

Intent: To allow an Alternate Delegate to be present, serve alongside and support the Zonal Delegate so they may function as a team in the same way as RD and AD teams can. The cost of attending the WSC for the Alternate Zonal Delegate would be the responsibility of the zone and each zonal delegate is limited to one alternate.

SUB COMMITTEE ACTIVITY

Central Wyoming Area has three sub committees: H&I, PR, and Literature


- H&I meets every month the Wednesday before the last Thursday of each month
 - New trusted servant stepped into Chair position!
 - Currently taking 5 meetings into various lock down facilities each month
 - (lost 2 since last report due to lack of trusted servant participation)
 - WBI and CWCC on hold for now. WBI started an acute treatment wing which our members are beginning filling out applications to gain entrance and bring an H&I meeting.
- PR meets every 2nd Wednesday of each Month
 - Stopped taking a panel into CWCC IOP meeting as the clients there generally wanted a H&I and/or meeting from members experience rather than what PR members were there to present. Offered to have a professionals only presentation.
 - Working on having a meeting with the school Reach, a troubled or struggling teens high school where they are required to get an AA sponsor and attend AA meetings but have not been allowed to get an NA sponsor. Supposed rational we've heard being "there are more felons in NA". PR hoping to clarify what NA can and cannot possibly do for them.
 - New Chair, lost two of five trusted servants so committee is readjusting to more limited resources.
 - Area passed new PR bylaws!
- Literature as outlined in CWA's by laws is a subcommittee, however the duties of this committee has been and is currently being taken care of by the Literature Chair and therefore doesn't meet on a monthly basis.
 - A home group motioned in July to dissolve literature committee and distribute current stock of literature evenly amongst home groups if a new Chair isn't found. Rational being the Area has needed a new Literature Chair for over a year now. Home groups responded against motion.
 - New Chair being apprenticed over 3 month period!
 - Continues operations of ordering literature and meeting material for the area,

home groups, and sub committees.

AREA ACTIVITY

Currently has 6 home groups, all located in Casper with 5 home groups participating at the area business meetings.

Good afternoon. The Activity that I reported on last time, the "Starry Night/Unity Day Campout" was met with some success. The turn-out wasn't very large but the members who attended had a good time and the Activities Project-team had a Speaker from Laramie, the same speaker who shared with us when we hosted the last RSC meeting in Laramie in August. Also, at the end of our ASC, it was decided to make a \$242.55 donation to Region, although I do not have the check with me as I did not get it from our new Treasurer.

Some ideas came to our last ASC meeting in August in the form of "motions", which our body hasn't dealt with since we moved away from Robert's Rules of Order and went to CBDM a few years ago. Since we only had two of six GSRs present, the ideas were sent back to the Groups until we meet next in November. The "ideas" which were brought forth were:

- 1. Moving the ASC to meeting every other month as opposed to our current "quarterly" format. 2. Going back to "rotating" the ASC, as opposed to our current "central" (meeting in Chevenne) format.
- 3. Re-visiting the idea of having an Area Literature Committee. All of these "motions", or ideas, were sent back to the groups to be brought back and discussed at our November ASC.
