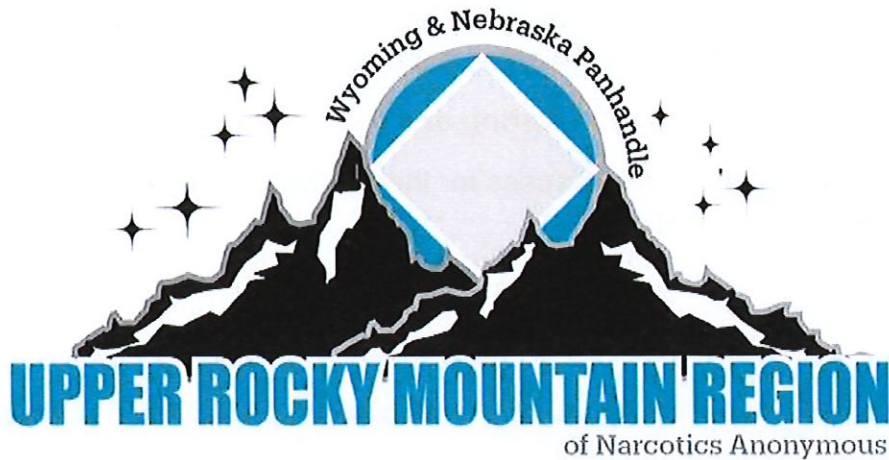

URMR Delegate Report 10/01/2022

Hello Regional Committee Members!

As much as I would like to say this will be a short report, we all know this is not going to be the case!

We attended one conference participant webinar, but a lot came out of that session, but first let's talk about projected expenses for both AD and RD to travel to the conference.

WSC 2023:

Hotel rates:

We were given the cost of the hotel. The room rate is \$159 per night, plus tax of \$24.88 = \$183.88 per room. Half of a room is \$91.94 per night. The length of the conference will be from Sunday April 30th to Saturday May 6th, 2023. We would need to fly in on Saturday the 29th and fly back out on Sunday the 7th. This will be a total of 8 nights needed for the rooms. NAWS will start making the reservations for the rooms in December and will go to March.

The total for both the RD and AD rooms will be \$1,471.04.

Airfare:

I have checked flights for traveling to and from the conference, I have an approximate cost of about \$320.00 per person. For both would be approximately \$640.00. The sooner we book the flights the less expensive they will be, of course the amount above is subject to change, so I would add about \$50.00 for any unexpected changes, making it \$690.00.

At this point, the projected cost without per diem, is \$2161.04.

Per Diem:

At the last conference I attended in 2018, the daily per diem requested was \$50.00 per day. It is now 4 years later and as we are all aware the cost of things has risen substantially. I would suggest we raise the daily per diem to \$60.00, for both, it would be \$120.00, at 8 days the total would be \$960.00.

Total costs for both AD and RD would be \$3,121.04. This does not include transportation for shuttles to and from the airport, an expense that I did not figure into my requested funds last time. We will need to add in some costs for transportation, but I have no clue the prices for this at this time, so possibly adding in another \$150.00 to the projected expenses bringing the total to **\$3271.04**

Re: epoll for 2023 CAR

The World Board polled conference participants recently to ask three questions to better prepare for the 2023 *Conference Agenda Report (CAR)* and what we call *CAR* season. We are writing to share the polling results and to let you know we plan to repoll one of the three questions. More information follows in this memo.

We received responses from 98 out of the possible 118 current regional delegates, 5 of the possible 6 zonal delegates, and the 13 World Board members. There are 5 regions without a delegate at the moment, for a total of 123 seated regions. The responses seem clear to two of the questions. Those questions and the responses are shown below. [Note: *abs* means *abstain*, and *pnv* means *present not voting*.]

Though the responses to the second question didn’t reflect a consensus, they gave us more information as we continue to explore options. This was not a vote – it was a straw poll to help the World Board better understand those we serve and we thank you for the feedback.

Like the first question about the Vision Statement motion, the question about the *FIPT* inspection clause is one that we need to answer in order to finalize the 2023 *CAR*, and the response was not as clear. We are planning to poll again with more options for response to see if that clarifies participants’ feedback. We separated out responses from regional delegates as they are currently the only deciders about the *FIPT*.

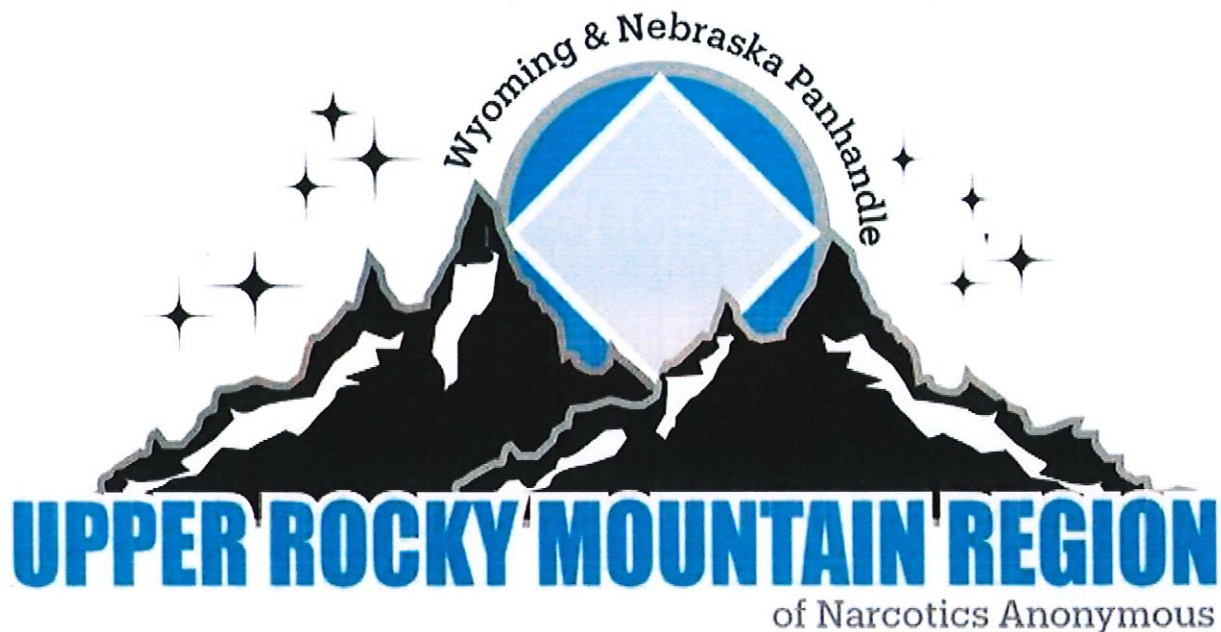

Good afternoon, the Delegate report covered most of the information needed. I will be reporting on NAWS updates that include:

Member's contributions were at an all-time high in the last fiscal year ending June 2022, at approximately \$2.2 million. Thank you to everyone that has helped and continues to help in this effort.

- We have three positions posted at NA World Services, but staffing is still well below pre-pandemic levels. At the beginning of the 2020 fiscal year, July 2020, we had 46 staff in Chatsworth. Once we fill the posted openings, we will hopefully have 29.
- Thanks to your contributions, we've been able to change our antiquated database software.
- The survey for *The Loner* came down at the end of August, and the DRT/MAT survey will stay up through November: na.org/survey.
- The Board is revising *Virtual Meeting Basics*, based on the input, and it will be posted very soon as board-approved service material.
- The Board was able to meet in person for the first time in well over 2 years in July. One of the big topics during this meeting was the upcoming CAR & WSC.

They are now taking orders for our new SPAD literature and the cost is \$13.00 not including tax & shipping.

H&I: The Refuge is still taking meetings up to Campbell County Detention Center every Sunday. They are only able to take meetings to the men due to lack of females and the jail just altered their requirements making it 5 years out of the jail, making it a little more difficult to find members that are eligible. New Freedom is doing H&I in the treatment center in Sheridan. The women's H&I meeting is getting around 10-12 attendees.

A motion was passed at the area to request that the Region provide books to all of the State D.O.C. facilities.

As far as the Grey books in the Campbell County Detention Center, I never went up and got them out as I was approached by an addict that told me it was breaking the concepts since it was a group conscience and group funds that were used to put them in there. I invited said addict to come and have a conversation with all of us this region about the issue at hand.

Activities: We did have another Area campout at Lake DeSmet that went really well. We had addicts from 3 different groups in the area show up, had an amazing speaker, fellowshiping was great, and was able to raise some money for our area through a raffle.

I was asked to be a workshop speaker at the next convention, so I just wanted to say thank you to the committee and everyone else involved in that decision. Im honored and ecstatic to be able to speak at our convention.
